2. APOLOGIES FOR ABSENCE


Apologies for absence were received from Councillors Wanstall and Howell-Bray (personal commitments).



14. QUESTIONS FROM THE PUBLIC

The Town Council considered questions received from Mr K Sansum pursuant to Standing Orders 1 (d) to (m) inclusive and 3b (v), concerning toilets in Dover.

- Q1 How many local businesses were contacted by Dover Town Council with its cash Incentive?
- A1 13 businesses have been directly approached as well as the information about the Community Toilet Scheme being available on the website and all Councillors actively promoting projects of the council including this one.
- Q2 How many responded?
- A2 4 businesses responded but none have joined the scheme largely because of concerns about mis-use and anti-social behaviour, which continues to be the main issues with public toilet provision in Dover alongside the very high costs.
- Q3 What plans does DTC have to help to Increase the number of toilets in Dover?
- A3 Dover Town Council has spent in excess of £50,000 over the past few years trying to increase the number of public conveniences in Dover in two ways additional to the Community Toilet Scheme and our award-winning Seafront Toilets operated at minimal cost to the precept payer through a contract with a Community Interest Company.

Firstly - through a planning application for new toilets at Riverside Gardens - the land was not made available after winning planning permission for a sustainable and flood resistant building;

Secondly - through front funding the development of the HLF bid to regenerate the Maison Dieu, which will contain high quality public conveniences.
