40. TOWN COUNCIL EXTERNAL REPRESENTATION

The Town Council noted the minutes of the Dover Town Team AGM held on 22nd October 2020.

The Town Council noted Councillor Brivio's update report on the current situation with the RV Coleman Trust, Dover Fairtrade Network Group, Food Pantry and development of the Community Café.

41. TOWN COUNCIL FINANCIAL INFORMATION

The Town Council considered the schedule of payments made by the Town Council for September, October and November 2020.

The Town Council considered the Town Council budget out-turn report to the end of November 2020.

The Town Council noted McCabe Ford Williams letter of 26th October 2020 concerning the recent internal audit.

The Town Council considered the External Auditor Report and Certificate 2019/20 in relation to the Annual Governance and Accountability Return 2019/20 and noted that there are no matters to which the auditors wish to draw the Council's attention. The Mayor thanked the Town Council Staff for their diligent hard work.

The Town Council noted that the relevant public notifications have been made in relation to the Annual Governance and Accountability Return 2019/20.

RESOLVED: a) The Town Council approved payments made in September, October & November 2020;

b) The Town Council approved the budget out-turn report to the end of November 2020.

42. TOWN COUNCIL 2021/22 BUDGET

The Town Council considered the Chairperson of the Council's report of 4th January 2021 concerning the Town Council's budget and precept for the 2021/22 financial year together with the Responsible Financial Officer's note and Revised Budget of 4th January 2021 issued following the receipt of the actual 2021/22 Band D Council Tax calculation from Dover District Council.

- RESOLVED: a) That the Town Council adopt the 2021/22 budget having taken note of all relevant factors including the proposed level of balances, expenditure and income trends and projections for the next three years, the capital programme transfers to reserves and contingencies and to delegate to the Proper Officer in consultation with the Mayor and Chairman of the Committee the authority to transfer such amounts as are necessary to/from and earmarked reserve with appropriate adjustment to the relevant budget;
- b) That the Town Council sets a precept of £831,200 for 2021/22, a Band D Council tax charge of £101.83 and a rise of 5% (or an average of 9.3p per week for an average household in Dover) on the previous year.

43. CYCLE HIRE SCHEME

The Town Council considered the Chairperson of the Council's report of 18th December 2020 concerning the acceptance and management of funding to provide a Cycle Hire Scheme in Dover by the Town Council.

- RESOLVED: That the Town Council accept funding for a cycle hire scheme in Dover from Kent County Council and to act as the accountable body; all contracts, arrangements and negotiations to be delegated to the Proper Officer in consultation with the Chairpersons of the Council.

44. EXCLUSION OF THE PUBLIC

- RESOLVED: That in accordance with Standing Order 7a(xvii) and in view of the confidential nature of the business about to be transacted it would be advisable in the public interest that the public be temporarily excluded and they be requested to withdraw for the duration of the agenda.

45. STAFFING

The Town Council considered the Chairperson of the Council's report of 17th December 2020 concerning the annual salary review.

- RESOLVED: That staff salaries are increased by 2.75% from April 2020.

46. DATE OF THE NEXT MEETING

The Town Council noted that the date of the next Town Council meeting is scheduled for Wednesday 24th March 2021.
