## **DECLARATIONS OF INTEREST**

## Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration, they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest' explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and subject to any dispensations, withdraw from the meeting. Members should remember that a finding of a breach of the law with regard to DPI's carries a fine of up to £5,000 and a criminal record.

## Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

## Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone they should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

#### Notes:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representatives on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer etc would both probably constitute either an OSI or in some cases a DPI.

## 1. INTRODUCTION

During the pandemic, Dover Town Council undertook a programme of projects to address different kinds of hardship caused by the lockdown in our community. Amongst these was the provision of food parcels and Christmas hampers to households which had suffered loss of income, financial difficulties or similar economic deprivation. Families received support at both Christmas and Easter and we know from feedback that this was a very much appreciated and popular kind of community support

## 2. INFORMATION

Households in Dover are amongst the most deprived in the UK and the pandemic and its aftermath has hit those people harder than most. Food is one of the essentials of life and Christmas with its traditional over indulgence and special focus on foods can be a very stressful and difficult time for households with low levels of income.

I am proposing that we repeat the Christmas Food Hamper project of 2020 and provide festive foods and a voucher to help around 50 economically deprived households in Dover enjoy the holiday season a little more than they would have been able to otherwise.

We are engaging with schools for recipient nominations but welcome input from councillors if they are aware of appropriate households in their wards. Once again, the trustees of St Radigund's community centre have agreed to provide the resources, personnel and space to pack and distribute the festive food packages and I am very grateful for their help and enthusiasm.

## 3. DECISION

## The committee is asked to resolve to:

Fund the provision of around 50 Christmas Food Hampers for households in Dover Town, which have suffered particular hardship during and following the Covid Pandemic up to £2500; all arrangements, purchasing decisions and operational detail to be delegated to the Proper Officer in consultation with the Chairperson of this Committee. Funds to be used from the Events Facilitation budget of 2021/22.
