DECLARATIONS OF INTEREST

Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration, they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest' explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and subject to any dispensations, withdraw from the meeting. Members should remember that a finding of a breach of the law with regard to DPI's carries a fine of up to £5,000 and a criminal record.

Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone they should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

Notes:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representatives on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer etc would both probably constitute either an OSI or in some cases a DPI.

This report is an overview of what has occurred since the last Community & Services Committee Meeting, up to the present day.

Allotment Vacancies are constantly advertised online & in Town Council notice board. Most allotment applications come via the Town Council Website

No major issues have arisen & all sites are at present running smoothly with a waiting list for each of them. To combat the waiting list regular inspections are being carried out to make sure all allotments are in use. Anyone found not tending their plot has been written to giving them formal notice to use the allotment or risk the council taking it back.

All Allotment licenses for 2024/25 have now been sent out. There has been a fluctuation with the waiting list recently but this isn't unusual this time of year when new tenancy year starts.

A date for asset inspection for the allotments is due to be set shortly.

High Meadow Local Nature Reserve

Report for Dover Town Council

January - March 2024

Site management

January and February have seen us busy clearing scrub and trees across High Meadow to increase the area of grassland. There have been rides created across most of Hospital Down, which will allow the Exmoor ponies to graze different areas and help keep back the

regrowth when they return.

The Dover rangers have had joint days onsite, clearing almost two thirds of the Prospect Field compartment as well as removing dangerous or unwanted trees across the site. However, it hasn't all been tree removal. One of the WCCP volunteers (also part of the Dover Wombles) donated 200 trees to us, and High Meadow received approximately 175 of those (with the others going to other WCCP sites). The trees were planted in the hedgerow along Noah's Ark Rd (see photo).

The area where we have scattered native seeds to improve biodiversity is showing promise, with two plants, meadow vetch and sorrel, already growing there. Neither of these plants were present last year. The ranger will continue to monitor this area and record the newly emerging plants.

We have ordered a replacement gate for the kissing gate at the top of the concrete steps on Noah's Ark Road, which was vandalised. This is due to arrive next week and will be installed before the Exmoor ponies return.

Community engagement

Regular site presence has led to greater/deeper engagement with site users and provides an opportunity to reinforce messages around responsible use of the site.

Our regular volunteers have been continuing to brave all weathers clearing scrub and removing rubbish. As the scrub clearing season is now over, we will be focusing on pathway and step maintenance to keep the site accessible throughout the spring and summer months.

Unfortunately, our first session with the Foreland Fields Duke of Edinburgh Gold Award students was rained off, but they will be having their first outing with us on Friday 8 March. We will be having a general site introduction/walk around, a talk about our work and why it's important before doing some practical management - they will be raking up cut materials and cutting vegetation away from paths. These sessions are to continue throughout the year, as often as we can facilitate between our schedules.

We are working to get a dog poo bin installed near the entrance at Edgar Rd/Prospect Place allotments, as the poo situation has worsened recently. There is agreement that there is a need for one and we are currently working on the logistics of it being emptied, with the roads being so tight in the area.

We attended the Tower Hamlets Community Day on Valentine's Day, with some fun collaging crafts of native birds for the children and volunteer information for the adults. Unfortunately, the weather meant not too many people turned up, but connections were made with Mind, the mental health charity, who think they have volunteers to send our way.

Looking Forward

The return of the Exmoor ponies is imminent, the National Trust are drawing up the grazing licence and then we are expecting a moving date to get them back- it was around this time last year.

We are hosting a litter pick on Sunday 17 March to take part in the Great British Spring Clean, which will be advertised on social media so could attract people from across Dover as well as local residents. We will be attending the St Radigund's Community Day in April with fun, nature-themed activities for children to do as well as trying to encourage locals to volunteer with us.

Management-wise, the ranger is keen to eradicate the invasive Canadian goldenrod and will be focusing on this during the summer. Regular cuts as well as new tools to destroy the roots will be tested with hopes of slowing down if not stopping its return.

Update on Community & Services Committee Initiatives

Grant Award to Ceramic Art Dover

The Community & Services Committee awarded a grant of £1,000 to Ceramic Art Dover to support the costs of its "Clay Date" event, held in July 2023. The funding enabled them to hold events attracting over 800 people.

It was a popular and free community event which invited and encouraged the local community and general public to experience and enjoy clay. A range of activities were provided including demonstrations of Raku firing. All activities were led by experienced ceramicists who live in and around Dover and East Kent.

• Edgar Road Development

The Council left Poulton Close in August "23" and has successfully moved to new premises at Edgar Road. The Wildlife friendly site will provide a volunteer hub, for the White Cliffs Countryside Partnership (WCCP). Alongside a new polycrub was installed this year, marking the Council's first year of growing its own plants. This initiative has resulted in significant savings as these plants have been used in planters and baskets throughout the Town this Summer. There will be an opening event for volunteers at WCCP later on in the Summer

Seafront Facilities Refurbishment

Following the very successful seafront survey & committee resolutions to improve facilities, the seafront toilets were upgraded & are now open all year round & free providing showers & changing facilities for sea lovers. The attached café has been remodelled and has become a popular venue with many weekly events & a community saunas.

• Funding for Canterbury Cycle Project at Betteshanger

The Committee funded the outfitting of a Betteshanger base for the Canterbury Cycle Project for £9,999. This project will deliver training, qualifications, and practical experience to Dover-based school and college students who are at risk of exclusion. The service level agreement for the building is in place & workshops are being equipped

Making Allotments Self sustainable

Through forward thinking and efforts of this committee, Maxton allotments is now self-sustainable relying solely on water harvested from the borehole and no longing using mains water.
